APPLICATION TO QUOTE GB ENERGY LIMITED OPTIONS ON THE AUSTRALIAN SECURITIES EXCHANGE

GB Energy Limited ("the Company") wishes to advise that it is applying for the quotation of 121, 721,385 options on the Australian Securities Exchange; of these 60 million were issued as part of the September 2010 placement. The remainder were issued as part of a non-renounceable rights issue that took place in December 2009. The options are exercisable at 3.5 cents per option on or before 29 July 2011.

Both placements raised a combined total of \$ 2,744,035 which has provided working capital, part of which is being used in the company's efforts in seeking oil & gas interests in Australia.
